ORDER

Shri Kamkhul Mossang, is hereby engaged as A/T on contractual basis against PAB 11-12 of Changlang district in the fixed pay of Rs.21175/- (Rupees Twenty-one Thousand One Hundred Seven-fifty) only with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shiksha Abbiyan.

The engagement is subject to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC);
 Special compensatory allowances etc.
- d) The Second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge course and any other departmental engagement.
- e) The contract teacher have to report his/ her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as cancelled.
- f) Hel she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- It the she will have to under gone DIFT training at concern DIET for Training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
