- c) He/She will have to produce Medical fitness certificate in prescribed form an authorized Medical Officer.
- d) The appointment is subject to Police Verification and he / she will be dismissed from Govt. service if any adverse reports are there with immediate effect.
- e) The other terms and condition of service which are not specified herein, shall be governed by the relevant rules and orders's inforce from time to time.
- f) Smti Chhanda Deb (Talukdar) shall have to continue for a minimum tenure of 3 (Three) years terms in his present posting place.


