ORDER

Approval is hereby accorded for the appointment of Miss Taring Mumpa, as Resource Person (English), under the head 'Academic Support through BRCs / URC', on contractual basis in the BRC and district mentioned against her name, in the fixed pay of Rs. 26,453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only per month till March 2018, under the centrally sponsored scheme of SSA. Further, she is directed to report to the Deputy Director of School Education of West Siang District for joining her duties in the BRC mentioned against her name as per contractual norms of SSA.

The appointment is subject to the following conditions:-

1. Her contractual service is purely temporary and can be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
2. She has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
3. The Marksheets / Certificates submitted by her for consideration are subject to verification from original source. In case of the forged Marksheets / Certificates she is liable to face legal action as per CCS Rule.
4. No earned leave is permissible except 12 days casual leave as per temporary central civil service leave rule.
5. During contract service period she is not entitled for medical reimbursement, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
6. The contract resource person has to report for her duty at posting place within fifteen days, failing which her appointment order will automatically be treated as cancelled.
7. She is not entitled to subscribe GPF, CGEIS or such other schemes during the period of contract service.
8. No representation will be accepted for change of posting place.
9. She has to undergo for RPs training as and when call for.
10. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
11. The selected Resource Person has to sign an agreement for contract service before receiving the appointment order.
