is hereby appointed to officiate as Jr. Teacher (S/S) in the
scale of pay of Rs. 1700-40-1600-50 - 3300-60-3600/- P.M. plus
other allowances as admissible under rules from time to time with
effect from the date he/she actually reports for duty to the DDPI/
Principal, H.S. School/Headmaster, Secondary School Along & posted to
Dara Middle school

2. The Officer shall be on probation for a
period of 2(two) years with effect from the date of joining. His/
her continuation in service beyond probation period of two years
is subject to satisfactory performance during probation period.

3. The appointment is subject to the
following conditions :-

- (a) The appointment is purely temporary and may be terminated
at any time without assigning any reasons after serving
one months notice. If he/she wants to resign may require
to give one months notice or surrender one months salary.
- (b) After joining in the duty he/she shall have to take oath
of allegiance of affirmation to the constitution of India
in the prescribed form.
- (c) He/she will have to produce medical fitness certificate
in prescribed form from an authorised medical Officer.
- (d) The appointment is subject to Police Verification and
he/she will be dismissed from Govt. Service if any
adverse reports are there with immediate effect.

4. The other terms and conditions of Service
which are not specified herein shall be governed by the relevant
rules and order in force from time to time.

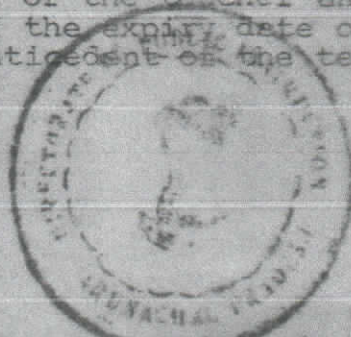
5. He/she will be transferred to schools anywhere in A.P.


