ORDER

Shri/Smtl/Miss Raja Rekhung is hereby appointed as A/T on contract basis in the fixed pay of Rs. 7200/- (Rupees Seven thousand two hundred) only with effect from the date of joining. In the concerned school for a period of one year against centrally sponsored scheme of sarva Shiksha Abhiyan. He/ She is posted to Prry. school Jongji Havi under Khimyang circle, District Changlang.

The appointment is subject to the following condition:-

- The contract appointee has no right to claim from regular appointment/regularization of post after expiry of contract appointment.
- No earned leave is permissible except casual leave as per CCS Leave rule and as per terms and conditions mentioned in the agreement form.
- During contract service period he / she is not entitled for medical re-imburement/ winter allowance / children education allowance/ special compensatory allowance.
- The contract appointee have to report his / her duty at posting place within 7 (seven days of issue of the appointment order failing which his / her appointment will automatically be treated as cancelled.
- He/ she is not entitled to subscribe to G.P.F or C.G.E.I.S or such other schemes during the period of contract service.
- No TA/DA will be granted to him for journey period for reporting to the training centre from his/ her place of posting and back to his/ her posting place after the completion of training.
- The other terms and conditions of the service which are not specified here shall be governed by relevant rules and orders enforce from time to time, and the terms and conditions mentioned in agreement signed by him.

- The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course & remedial teaching and any other departmental engagement.
- The contract teachers have to report his /her duty at posting place within 5(five) days and submit joining report through respective school, failing which his/her engagement order will be automatically be treated as cancelled.
- He/she is not entitle to subscribed GPF or CGEIS or such other scheme during the period of contract services.
- The engaged teachers are also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- No representation will be accepted for changing of posting place.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in force at time to time.
- The engaged teachers have to sign an agreement for contract engagement before receiving this engagement order.
