

- in excessed time to time.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order.
- i) He/she will have to under gone DIFT training at concerned place.
- h) No representation will be accepted for change of posting.
- g) The engaged Teacher is also to work as Volunteer Instructor for TLC programme for the interests of Literacy in Arunachal Pradesh in addition to his/her normal duties.
- f) He/she is not entitled to subscribed GPF or GRI's or such order will automatically be treated as cancellation.
