In pursuance of Govt. Approved Vide No. E.O.No. 733 Dated 27/01/2014, Sri. Bijay Yadav, B.A. passed is hereby appointed temporarily as Assistant Teacher (AT) on the compassionate ground in the scale of pay PB 25300-34800 + GP-1200 + P.M plus other allowances as admissible under rules from time to time with effect of the date he/she actually reports for duty at Govt. Primary School, Rengang under DISE, Pasighat, East Siang district.

The appointment shall be on compassionate ground as Govt. of India Ministry of Home Affairs Order No. 1101/2000 Estt (D) dated 09/12/93. The appointment is made against the vacancy of Smt. Chaleshina Tayeng, A.T.M, voluntary retired.

The Appointment is subjected to the following conditions :-

1. The appointment is on probation for a period of 03 (three) years. During probationary period, his/her service may be terminated at any time without any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
2. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
3. The appointment is subjected to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
4. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
5. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
6. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.
7. On their appointment as Assistant Teachers he/she should undergo compulsory in-service D.El. Ed. B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
