## ORDER

- (ii) The appointment is purely on temporary and may be terminated with 1(one) month notice. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is Subject to the Police Verification and he / she will dismissed from government service if any adverse report is there with immediate effect.
- (vii) He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of minimum 3(three) years of service in the posting place.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
