

The above appointments are subject to the following conditions :-

- The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
- After joining duty he/she will have to take an oath of allegiance to give affirmation to the Constitution of India in the prescribed form.
- She/he will have to produce a Medical Certificate from an authorised medical Officer to the effect that he/she is medically fit for the Government Service.
- The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there by any adverse remarks against him/her in the Police report.
- The appointments are for a probation period of 2 (two) years. If the work and conduct of the teacher is not found satisfactory, he/she may be terminated.
