2. The Officer shall be on probation for a period of 2(two) years with effect from the date of joining. His/Her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

- (b) After joining in the duty he/she shall have to take an Oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (c) He/She will have to produce Medical Fitness Certificate in prescribed form from an authorised Medical Officer.
- (d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. service if any adverse reports are there with immediate effect.


