ORDER

Miss Amum Dai is hereby appointed as TGT (Science & Maths) contract in the fixed pay of Rs. 26453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only with effect from the date of joining in the concerned school up to 31st March, 2018 under the Centrally Sponsored Scheme of Sarva Siksha Abhiyan. He is posted at Govt. Upper Primary School, Jarkong.

The appointment is subject to the following conditions:-

1. The contract teacher has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
4. The contract teacher have to report his/ her duty at posting place within 07 (Seven) days from the date of joining in the office of concerned school, failing which his/ her appointment order will be treated as cancelled.
5. He/ She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
6. The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of Literacy in Arunachal Pradesh in addition to his/ her normal duties.
7. No representation will be accepted for change of posting place.
8. He/ She will have to undergo DIET training at concern DIET for training as and when call for.
9. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
10. The appointed teacher has to sign as agreement for contract engagement before receiving this engagement order.
