## ORDER

- The contract teacher has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
- No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and condition mentioned in the agreement copy.
- During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- 4. The contract teacher have to report his/ her duty at posting place within 07 (Seven) days from the date of joining in the office of concerned school, failing which his/ her appointment order will be treated as cancelled.
- He/ She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
- 6. The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of Literacy in Arunachal Pradesh in addition to his/ her normal duties.
- 7. No representation will be accepted for change of posting place.
- 8. He/ She will have to undergo DIET training at concern DIET for training as and when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- 10. The appointed teacher has to sign as agreement for contract engagement before receiving this engagement order.
