ORDER

In pursuance of Govt. approval vide U.O. No. Dated 03/03/2008 the service of Shri/Smti/Miss Opet Gao (Taggu) is hereby regularized temporarily to officiate as Assistant Teacher(A) in the Scale of Pay of Rs.4500-125-7000 p.m. plus other allowances as admissible under Rules from time-to-time w.e.f. he/she actually reports for duty to the DDSE, Yupia, Papum Pare District, Arunachal Pradesh. He/She is posted under disposal of DDSE, Yupia. He/She is appointed against Shri/Smti Nyakjum Gama, AT(A) promoted to JT.

The appointment shall be on probation for a period of 02(two) years w.e.f. the date of joining. His/Her continuation in service beyond probation period for 02(two) years is subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:

- a) The appointment is purely temporary and will be terminated with 01(one) month notice. If He/She wants to resign, he/she may do so after giving 01(one) month notice or by surrendering 01(one) month salary.
- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect

The terms and conditions of service which are not specified herein shall be governed by the relevant Rules & Orders in force from time-to-time.
