**ORDER.**

Miss Leena Tangha is hereby appointed as Asstt. Teacher on contract basis in the fixed pay of Rs 7200/- (Rupees Seven Thousand two Hundred ) only with effect from the date of joining in the concern School up to 31<sup>st</sup> March/2010 against Centrally Sponsored Scheme of **Sarva Shiksha Abhiyan**. She is posted at Govt. Sec.School, Yanman under Khimyang Circle.

The appointment is subject to the following conditions :-

- a) The contract teacher has no right to claim for regular appointment /regularization of the post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period she is not entitle for medical reimbursement ,winter allowances, children educational allowances ,reimbursement of tuition fees, leave travel concession(LTC) ,special compensatory allowances etc
- d) The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement
- e) The contract teacher have to report her duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will be automatically be treated as cancelled.
- f) She is not entitle to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/ her normal duties.
- h) No representation will be accepted for changing of posting place.
- i) She will have to under gone DIET training at DIET Changlang for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- k) The appointed teacher has to sign an agreement for contract engagement before receiving this engagement order.
