- The appointee will not have any claim whatsoever for the services rendered by him or her as a JT (Contract) from the date of their initial appointment till the date of regularization i.e. 01.05.2007 regularizations is effected from 1st May'2007.
- The appointment order shall be cancelled, if the appointee directly or in-directly campaign for change posting or does not join within 10(Ten) days from the date of issue of this order.
