- a) The contract Teacher has no right to claim regular appointment /regularization of the post after expiry of contract engagement.
- b). No Earned leave is permissible except casual leave as per central civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c). During the contract Period he/she is not entitled for medical reimbursement : winter allowance: children education allowance : reimbursement of tuition fees: leave travel concession (LTC): Special compensatory allowance etc .
- d). The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DPO failing which his/her engagement order will automatically be treated as cancelled.
- e). He/ She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f). The engaged teacher is also to work as volunteer instructor for TLC programme for interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g). no representation will be accepted for change of posting place.
- h). He/ She will have to undergo GIET training at concerned DIET for training as and when call for.
- i). The other terms and conditions of Service which are not specified shall be governed by the relevant rules and order in forced time to time
- j). The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
