

**ORDER**

Miss Tenzin Tseyang, Daughter of Shri Tenzin, Kelengteng Village is hereby engaged as **PART TIME TEACHER** on Contract Basis in the fixed pay of Rs. 5,000/- (Rupees Five Thousand) only per month with effect from the date of joining against Centrally Sponsored Scheme of ISSE Samagra Shiksha Abhiyan Society, Tawang.

The engagement is subject to the following conditions:-

1. The services of the employed on contract basis has no rights to claim for regular appointment/regularization of the post after expiry of the contract engagement.
2. No leaves are permissible except Casual Leave as per Central Civil Service Rule and as per Terms and conditions mentioned in the Deed of Agreement.
3. He/She will not be entitled to subscribe to Special Compensatory Allowances, Winter Allowances and Medical Re- imbursement, Children Education Allowances, Re-imbursement of Tuition Fees, Level Travel Concession (LTC), and any other advances as permissible to other regular Govt. servants.
4. He/She is not entitled to subscribe to GPF or CGEIS or such other welfare scheme during the period of contract service.
5. He/She has to report at the given posting place within 7 days from the date of joining in the DPO Office, Failing which his/her engagement order will automatically be treated as cancelled.
6. He/She should be ready to serve at any place/schools including those located in remote interior areas. In case of refusal the appointment order will be treated as cancelled. No representation what so ever will be entertained.
7. He/She will have to undergo any training for any duration as and when called for. He/She is also to work as Volunteer Instructor of the total Literacy Campaign for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. He/ She placed 1(one) year probation and the renewal of his /her contractual service be based on the performance only.
9. The other Terms and condition of services shall be governed by the relevant rules and order enforced time to time.
