ORDER

The contractual service Shri Takhe Tade is hereby regularized to officiate as Assistant Teacher in Scale of pay of Rs.4500-125-7000- p.m. plus other allowance as admissible under rules from time to time with effect from 08/03/2004. He/she is posted under the disposal of DDSE, ZIro, District, Lower Subansiri, A.P.

The regularization is made vice Shri Bomluk Gamlin, AT. promoted.

2. The incumbent shall be on probation for a period of 2 (two) years with effect from the date 08/03/04. His / her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

The regularization is subject to the following conditions :-

- a) The regularization is purely temporary and may be terminated at any time without assigning any reasons. If he/she wants to resign he may do so after giving one month's notice or by surrendering one month pay.
- b) After joining the duty he/she shall have to take on Oath of allegiance of affirmation to the constitution of India in the prescribed form.
- c) He/She will have to produce Medical fitness certificate in prescribed form an authorized Medical Officer.
- d) The appointment is subject to Police Verification and he / she will be dismissed from Govt. service if any adverse reports are there with immediate effect.
- e) The other terms and condition of service which are not specified herein, shall be governed by the relevant rules and orders's inforce from time to time.
- f) Shri Takhe Tade shall have to continue for a minimum tenure of 3 (Three) years terms in his present posting place.


