prescribed form.
- (c) He/She will have to produce medical fitness certificate in
prescribed form from a authorized medical officer.
- (d) The appointment is subject to Police Verification and he/she
will be dismissed from Govt. service if any adverse reports are
here with immediate effect.

The other terms and conditions of service which
are not specified herein shall be governed by the relevant rules and
order in force from time to time.

He/She will be transferred to schools any where
in Arunachal Pradesh.

No application will be entertained for changing of
posting places.
