## ORDER

In pursuance of Govt. approval vide U.O. d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.

e) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if there is any adverse report against him/her.

f) On joining, the appointee shall have to serve for a minimum of 02 (two) years at the place of posting.

g) Seniority of the appointee will be based strictly on merit list.

h) The appointment order shall be cancelled, if the appointee directly or indirectly campaign for change of posting or does not join within 20 (twenty) days from the date of issue of this order at posing place.

The terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
