## ORDER

(iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.

(v) He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.

(vi) The appointment is Subject to the Police Verification and he / she will dismissed from government service if any adverse report is there with immediate effect.

(vii) He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
