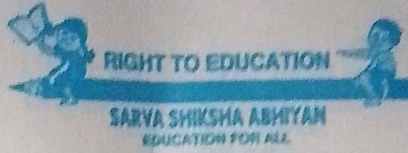
ORDER

Mr. Rinchin Dorjee Namsa is hereby engaged as **Trained Graduate Teacher** on contract basis in the fixed pay of Rs. 26453/- (Rupees Twenty Six Thousand Four hundred fifty three) only with effect from the date of joining in the concerned School of the district up to 31st March'2019 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at **Govt. Middle School, Balemu**.

The engagement is subject to the following conditions:-

- a. The contract teacher has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period he/ she is not entitled for Medical Reimbursement, winter allowance, children educational allowance, reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- d. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- f. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to her normal duties.
- g. No representation will be accepted for change of posting place.
- h. She will have to undergo DIET training at the concerned DIET for training as and when called for.
- i. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.


