- c) She/he will have to produce a Medical Certificate from an authorised medical officer to the effect that he/she is medically fit for the Government Service.
- d) The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there by any adverse remarks against him/her in the Police report.
- e) The appointments are for a probation period of 2(two) Years. If the work and conduct of the teacher is not found satisfactory, he/she may be terminated.

The other terms and conditions which are not specified here in would be governed by the rules and orders that may be in force from time to time.
