She is temporarily attached at Govt. Residential School, Melongkhar till further order.

The engagement is subject to the following conditions:-

- The services of the employed on contract basis has no rights to claim for regular appointment/regularization of the post after expiry of the contract engagement.
- No leaves are permissible except Casual Leave as per Central Civil Service Rule and as per Terms and conditions mentioned in the Deed of Agreement.
- He/She will not be entitled to subscribe to Special Compensatory Allowances, Winter Allowances and Medical Re- imbursement, Children Education Ailowances, Re-imbursement of Tuition Fees, Level Travel Concession (LTC), and any other advances as permissible to other regular Govt. servants.
- He/She is not entitled to subscribe to GPF or CGEIS or such other welfare scheme during the period of contract service.
- He/She have to report at the given posting place within 7 days from the date of joining in the DPO
 Office, Failing which his/her engagement order will automatically be treated as cancelled.
- He/She should be ready to serve at any place/schools including those located in remote interior areas. In
 case of refusal the appointment order will be treated as cancelled. No representation what so ever will
 be entertained.
- He/She will have to undergo any training for any duration as and when called for. He/She is also to work
 as Volunteer Instructor of the total Literacy Campaign for the interest of literacy in Arunachal Pradesh in
 addition to his/her normal duties.
- The other Terms and condition of services shall be governed by the relevant rules and order enforced time to time.
