The regularization is made vice new created post vide order No. 3/39/99-2000 Dtd.18.01.02.

The incumbent shall be on probation for a period of 2 (two) years with effect from the date of 27/12/2004. His/ her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

The regularization is subject to the following conditions:-

1. The regularization is purely temporarily and may be terminated at any time without assigning any reason. If he/ she want to resign he may do so after giving one month's notice or by surrendering one month pay.
2. After joining the duty he/ she shall have to take an Oath of allegiance of affirmation to the constitution of India in the prescribed form.
3. He / she will have to produce Medical fitness certificate in prescribed form an authorized Medical Officer.
4. The appointment is subject to Police Verification and he/ she will be dismissed from Govt. service if any adverse reports are there with immediate effect.
5. The other terms & condition of service which are not specified herein shall be governed by the relevant rules and order's inforce from time to time.
6. Shri Phuntso Tsering shall have to continue for minimum tenure of 3 (three) years terms in his present posting place.






