ORDER

Miss Ponung Moyong is hereby appointed as A/T (Sc) contract in the fixed pay of Rs. 10800/- (Rupees ten thousand eight hundred) only against the vacancy created due to the death of Sri. Tayor Siram A/T(Sc) with effect from the late of joining in the concerned school upto 31st March, 2012 under the Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/She is posted at Govt. Upper Primary School, Remi (Ruksin Block).

The engagement is subject to the following conditions: -

- 1) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- 2) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- 3) During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- 4) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- 5) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
- 6) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- 7) No representation will be accepted for change of posting place.
- 8) He/she will have to under go DIET training at concern DIET for Training as and when call for.
- 9) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- 10) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
