**ORDER**

In pursuance of Govt. approval vide U.O. No. Nil dated 22/06/2009, Ms. Kalpana Das Sharma is hereby appointed temporarily to officiate as Senior Teacher(Hindi) in the scale of pay of Rs.6500-200-10500/- p.m. plus other allowances as admissible under rules from time to time. He/She is posted at Govt. H.S. School, Raga under the disposal of the DDSE, Ziro, Lower Subansiri District, Arunachal Pradesh.

He/She is appointed against newly created post vide order No.ED.3/105/2008-09 dtd.09/6/08.

2. The appointee shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His/her continuation in service beyond probation periods for 2 (two) years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions:-

- a) The appointment is purely temporary and may be terminated with 01(one) month notice. If He/She wants to resign, he/she may do so after giving 01 (one) month notice or by surrendering 01 (one) month salary.
- b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- c) After joining duty, he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- e) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if there is any adverse report against him/her.
- f) On joining, the appointee shall have to serve for a minimum of 02 (two) years at the place of posting.
- g) Seniority of the appointee will be based strictly on merit list.
- h) The appointment order shall be cancelled, if the appointee directly or indirectly campaign for change of posting or does not join within 20 (twenty) days from the date of issue of this order at posing place.

The terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.


