Shri Ajay Kumar Das, M.Com., B.Ed. is hereby appointed temporarily to officiate as Senior Teacher (Commerce) in the scale of pay of Rs.6500-200-10,500/-PM plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duties to the Principal, Govt. Hr.Sec. School, Seppa, East Kameng District, Arunachal Pradesh in the first week of June/07 after summer vacation.

The appointment is made against newly created post vide order No.ED.3/248/2006-07 dated 19<sup>th</sup> March,2007.

The appointment is subject to the following conditions :-

- a) The appointment is purely temporary and his services may be terminated at any time without assigning any reasons after giving one months notice from either side.
  - b) After joining duty he will have to take an Oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.
  - c) He will have to produce Medical Certificate from an authorized Medical Officer.
2. The appointment is subject to the police verification and he will be discharged from service with immediate effect if there be any adverse remarks against him in the police reports.
3. The other terms and conditions which are not specified here would be governed by the rules and order that may inforce from time to time.


