  3. After joining duty He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- The appointment is subjected to Police Verification and He/She will be dismissed from service if any adverse report is found against him/her with immediate effect.
- 5. After joining duty He/She will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.

  6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place
- 7. The seniority of the appointee shall be based strictly on merit list.

  8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.
- 9. On their appointment as Junior Teachers they should undergo compulsory in-service B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force form time to time.
