ORDER

Shri/Smti/Miss/Mrs *Lomyar Nibang*
is hereby appointed temporarily to officiate as *A/T 'A'* under the Education Department, Govt. of Arunachal Pradesh and posted to *Yudik Poy* school in the scale of pay Rs. ~~1400-80-150-50-50-2000~~ plus other allowances as admissible under the rules from time to time with effect from the date on which he/she reports for duty to the place of posting *Yudik Poy (Dumpon)*

The appointment is subject to the following conditions:-

No representation will be entertained in this respect before completion of five years.

A) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month notice from either side.

B) After joining duty he/she will have to take an oath of allegiance or give affirmation to the constitution of India duly filled in the prescribed form.

C) He/She will have to produce a MEDICAL CERTIFICATE from an authorised Medical Officer to the effect that he/she is medically fit for the govt. service.

D) The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.

The other terms and conditions which are not specified here would be governed by the rule and order that may be in force from time to time.

Candidate should join the posting place within 10 (ten) days failing which appointment will stand cancelled.
