

ORDER

Director of Public Instruction, Tezu.

The appointment is subjects to the following conditions: -

- a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
  - b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the constitution of India in the prescribed form.
  - c) He/She will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for the Government service.
