2. The appointment is subject to the following conditions:-

a. The appointment is purely on probation for a period of 2 (two) years and may be terminated at any time without assigning any reason after giving one month's notice from either side.

b. After joining duty he/she will have to take an oath of allegiance of give affirmation to the Constitution of India duly in the prescribed form.

c. He/She will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for the Govt. Service.

3. The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there will be any adverse remarks against him/her in the Police report.

4. The teacher must join his/her duties at his/her place of posting within 30 (thirty) days from the date of ~~receipt~~ of this order.

5. The other terms and conditions which are not specified here would be governed by the rules and orders that may/in force from time to time.
