// ORDER //

Shri/Smt/Miss. J. King's Bangsia..... is hereby engaged as Actg. Teacher.... on contract basis in the fixed pay of Rs. 7200/-..... (Rupees Seven thousand two hundred) only with effect from the date of joining in the concern posting place upto 31st March, 2009 against Centrally sponsored scheme of Sarva Shiksha Abhiyan. He/She is posted at Primary/Middle School of Khonsa block. Place of posting will be decided at completion of induction level training

The engagement is subject to the following conditions-

- 1) The contract teachers have no right to claim for regular appointment/ regularisation of the post after expiry of contract engagement.
- 2) No earn leave is permissible except Casual Leave as per Central Civil Service rule and as per terms and condition in the agreement copy.
- 3) During contract service period He/ She is not entitled for medical re-imburement, Winter Allowances, Children's Education Allowances, Reimbursement of Tuition fees, Leave Travel Concession (LTC) Special Compensatory Allowance etc.
- 4) The contract Teachers have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the District Project Officer's Office, Khonsa failing which His / Her engagement order will automatically be treated as cancelled.
- 5) He/She is not entitled to subscribe GPF or CCEGIS or such other schemes during the period of contract services,
- 6) The engaged Teacher is also to work as Volunteer Instructor for TLC/PLP programme for the interest of Literacy in Arunachal Pradesh in addition to his/her normal duties.

- 7) No representation will be accepted for the change of Posting place.
- 8) He/she will have to undergo DIET Training at Changlang ~~DIET~~ DIET for training as and when called for.
- 9) The other terms and conditions of the services which are not specified shall be governed by the relevant rules and ~~###~~ order enforced time to time.
- 10) The engaged Teachers has to sign an agreement for contract engagement before receiving this engagement order.
