DTE, DWS Navsmit **Sri. Yumni Nada** is hereby appointed as TGT on contract basis in the fixed pay
Rs. 23,113-11 plus some thousand more hundred seventy five only with effect from the date
of joining in the School against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is
posted at East Primary School, Chanlang.

The appointment is subject to the following conditions:

- a) The contract teacher has no right to claim for regular appointment of the post after expiry of contract appointment.
- b) No casual leave is permitted except casual leave as per Central Civil Service Leave Rules as per terms and conditions mentioned in the agreement copy.
- c) During contract service period, he/she is not entitled for medical reimbursement, winter allowances, children educational allowances, reimbursement of school fees, leave travel concession (LTC), special compensatory allowances etc.
- d) The second party shall be entitled for dearness salary of only for the academic session. No work No pay policy is enforced to the second party.
- e) The contract teacher has to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the DDESR, failing which his/her engagement order will be automatically be treated as cancelled.
- f) He/she is not entitled to subscribed GPF or CDF or other schemes during the period of contract service.
- g) The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for changing of posting place.
- i) He/She will have to under gone DDESR training at DDESR Changlang for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules as in orders in force at the time.
- k) The appointed teacher has to sign an agreement for contract before receiving this engagement order.
