ORDER

✓ Shri Uffa Manpoorj is hereby engaged as Assistant Teacher on contract basis in the fixed pay of Rs.720).00 (Rs. Seven Thousand Two Hundred) only With effect from the date of joining in the Govt. Primary/ Middle/ School Lekang Mhanti Up to 1(One) Year against the centrally sponsored scheme of SSA.

He/She is temporarily attached to Govt. Primary/ Middle/ School _____ till completion of school building at Lekang Mhanti under SSA to be opened.

The engagement is subject to the following conditions.

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances and any other such allowances.
- d) The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE,s office failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/ her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to undergone DIET training at concerned DIET for training as and when called for.
- i) The other terms and conditions of services which are not specified shall be governed by the Relevant rules /Orders / Guide lines / Instruction in force time to time.
- j) ~~The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.~~
- k) His/Her contractual service will remain valid only up to 31st May'2009 and thereafter it will be treated automatically terminated and a fresh renewal would be required.
- l) He / She will have to report for duty at his / her posting place positively on 2nd June'2008. His / her Pay will be drawn on y after getting joining report through the concerned A P O (AE) / A D E O
