- 3. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
- 4. The contract teacher have to report his/her duty at posting within 7(seven) days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- 5. He she is not entitled to subscribe GPF/CGEIS or such other schemes during the period of contract services.
- 6. The engaged teacher is also to work as volunteer instructor of TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./Dist. Administrator/Education Department in any addition to his/her normal duties.
- 7. No representation will be accepted for change of posting place.
- 8. The other terms and conditions of service which are not specified shall be governed by the relevant rules/orders/guidelines/instruction in force time to time.
- 9. The engaged teacher has to sign an agreement for contract agreement before receiving this engagement order.
- 10. His/Her contractual service will remain valid for 1 (one) year and thereafter it will be treated automatically terminated and a fresh renewal will be required.
