ORDER

Smt / Smt Peter Lishi is hereby engaged as
Assistant Teacher on contract basis in the fixed pay of Rs.7200-00 (Rs. Seven Thousand Two Hundred) only
With effect from the date of joining in the Govt. Primary Middle/ School
Hatiduba Up to 7/04/08 against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions.

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement, winner allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances and any other such allowances.
- d) The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF / CGPF or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration Education Department in any addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to undergo DIET training as a co- worker DUTY for training as and when called for.
- i) The other terms and conditions of services which are not specified shall be governed by the Relevant rules /Orders / Guide lines / Instructions in operation to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k) His/her contractual service will remain valid only up to _____ and thereafter it will be treated automatically terminated and no work should be required.
- l) He / She will have to report for duty at his/her posting place positively on _____. His / her Pay will be drawn only after getting joining report through the concerned A P O (AE) / A D E O
