ORDER

- On joining, the appointee shall have to serve for a minimum of 2 (two) years at the place of posting.
- The seniority of the appointee will be determined strictly on merit list in which he/she had been selected for appointment
- The appointment order shall be cancelled, if the appointee directly or in-directly campaign for change of posting or does not join within 10 (ten) days from the date of issue of this order.
