Mr. Kabang Rome is hereby appointed temporarily to officiate as Assistant Teacher (A) in the pay of Rs. 9300-34800+GP, Rs. 4200-PM plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the Headmaster, Govt. Sec. School, Pakke-Kessang, East Kameng District under DDSE, Seppa, Arunachal Pradesh.

The appointment is made against Shri Rinchin Riju, AT (A) Promoted to JT(non plan) post.

The appointment shall be on probation for a period of 2 (two) year w.e.f. the date of joining. His /Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

5. After joining duty he/she will have to taken an oath of allegiance of affirmation to the Constitution in the prescribed form.
6. On joining, the appointee shall be serve for a minimum period of 3 (three) years at the place of posting.
7. The seniority of the appointee shall be based strictly on merit list.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does join with 20 (twenty) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force time to time.
