ORDER

M/s/Ms. *Egashu Neta* is hereby engaged as **Asst Teacher** on contract basis in the fixed pay of Rs. 21,125/- (Rupees Twenty one thousand one hundred and twenty five) only per month with effect from the date of joining in the Govt. *Primary School, Tengnabuk*, up to 1(One) Year against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions

- (a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- (b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- (c) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances and any other such allowances.
- (d) The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- (e) He/she is not entitled to subscribe GPF / CGPS or such other schemes during the period of contract services.
- (f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/her normal duties.
- (g) No representation will be accepted for change of posting place.
- (h) He/she will have to undergo DME-I training at concerned DME-I for training as and when called for.
- (i) The other terms and conditions of services which are not specified shall be governed by the Relevant rules / Orders / Guide lines / Instruction in force time to time.
- (j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- (k) His/Her contractual service will remain valid only up to Summer vacation 2012 and thereafter it will be treated automatically terminated and a fresh renewal would be required.
- (l) He / She will have to report for duty at his / her posting place positively within 07 days . His / her Pay will be drawn only after getting joining report through the concerned
