engaged as Assistant Teacher on Contract Basis at the fixed Pay of Rs. 720/-  
Rupees Seven Thousand Two hundred/- only per month with effect  
from the date of joining against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions:

1. The servitor of the employee on contract basis has no right to claim for regular appointment / regularization of the post after expiry of the contract engagement.
2. No leave is permissible except as may be availed as per Central Civil Service Rule and as per terms and Conditions mentioned in the Deed of Agreement.
3. He/She will not be entitled to Special Compensation Allowance, Winter Allowance, Medical Re-imbursement, Children Education Allowance, Re-imbursement of Tuition Fees, Level Travel Concession (LTC), and any other advances or commissaries to other regular Govt. servants.
4. He/She is not entitled to subscribe to GPF or CGHS or such other welfare schemes during the period of contract service.
5. He/She have to report at the given posting place within 7 days from the date of joining in the DPO Office, failing which his/her engagement order will automatically be treated as cancelled.
6. He/She should be ready to serve at any place - schools including those located in remote interior areas. In case of refusal, the appointment order will be treated as cancelled. No representation whatsoever will be entertained.
7. He/She will have to undergo any training for any duration as and when called for. He/She is also to work as Volunteer Instructor of the Total Literacy Campaign for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. The other Terms and Conditions of service shall be governed by the relevant rules and order effective time to time.
