The engagement is subject to the following conditions.

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- No earned leave is permissible except casual leave as per casual civil service leave rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances and any other such allowances.
- The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- He/she is not entitled to subscribe GPF / CGPF or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor of TLC / PLI programme in the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration Education Department in any addition to his/her normal duties.
- No representation will be accepted for change of posting place.
- He/she will have to undergo the DIST training as conducted by DIST for training as and when called for.
- The other terms and conditions of service which are not specified shall be governed by the Relevant rules / Orders / Circulars / Instructions in force from time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- His/Her contractual services will remain valid only up to _____ and thereafter it will be treated automatically terminated unless he/she is again required.
- He / She will have to report for duty at the posting place positively on _____. His / her Pay will be drawn only after reaching posting place to the official concerned A.P.O (AE) / A.D.E.O
