31st May 2009 against the centrally sponsored scheme of SSA.

He /She is temporarily attached to Govt. Primary/ Middle/ School Loilia
till completion of school building at _____ under SSA to be opened.

The engagement is subject to the following conditions.

- The contract teacher has no right to claim for regular appointment / regularization of the post after the completion of contract period.
- No earned leave is permissible except casual leave as per central civil service leave rule and as per condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical reimbursement; winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC) and compensatory allowances and any other such allowances.
- The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE,s office failing which his/her engagement order will automatically be cancelled.
- He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the illiterate in literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in addition to his/ her normal duties.
- No representation will be accepted for change of posting place.
- He/she will have to undergo DIET training at concerned DIET for training as and when called.
- The other terms and conditions of services which are not specified shall be governed by the rules /Orders / Guide lines / Instruction in force time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- His/Her contractual service will remain valid only up to 31st May'2009 and thereafter it will be automatically terminated and a fresh renewal would be required.
- He / She will have to report for duty at his / her posting place positively on 2nd June'2008. His / Her salary will be drawn only after getting joining report through the concerned A P O (AE) / A D E O.
