The provisions of this regulation shall be subject to the following conditions as mentioned in the Regulation (Ar. 1) in the case of the DSE. The other provisions in this regulation shall apply from the date of issue of this order to the extent to which it is not in conflict with the provisions of this regulation.

The regularization shall be on probation for a period of 2 years from the date of joining. The regularization period shall be subject to satisfactory performance during probation period.

**The regularization is subjected to the following conditions:-**

1. The regularization is purely temporary and may be terminated at any time by giving 1 month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering in month salary.
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The regularization is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take Oath as allegiances of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
7. On their appointment as Primary Teacher (AT-A), they should undergo compulsory in-service DUTY/PTED within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
