- The contract teacher has no right to claim for regular appointment/regularization of 20.3 the post after expiry of contract engagement
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy 61
- During contract service period he/she is not entitle for medical reimbursement; winter allowances, children educational allowances, reimbursement of tuition fees, () leave travel concession (LTC), special compensatory allowances etc
