an oath of allegiance for five affirmation to the constitu-
tion of India duly filled in the prescribed form.
- C) He/She will have to produce a Medical
Certificate from an authorised Medical Officer to the effect
that he/she is medically fit for Govt. Service.
- D) The appointment is subject to the police
verification and she/he will be dismissed from service
with immediate effect if there be any adverse remarks
against him/her in the police report.

order that may be in force from time to time.

Candidate should join the posting place
within 10 (ten) days failing which appointment will stand
cancelled.
