**O R D E R**

In pursuance of the State Project Director, Samagra Shiksha Manager, Approval No. SS-1(10)01/2022, On SPD - Samagra Shiksha Dant, Manager the 11/07/2022, Ms. Kothurn is hereby appointed as PRT (ISSE) in the Fixed pay of Rs. 14,000/- per month in place of Mr. Neon Kumar, PRT resigned on 9/5/2022, and posted her to the Govt. Upper Primary School, Kansat with immediate effect.

The engagement is subject to the following conditions:-

1. The services of the employed on contract basis has no right to claim for regular appointments/regularisation of the post after expiry of the contract engagement.
2. No leaves are permissible except Casual Leave as per Central Civil Service Rule and as per Terms and conditions mentioned in the Deed of Agreement.
3. He/She will not be entitled to subscribe to Special Compensation Allowances, Winter Allowances and Medical Re-imbursement, Children Education Allowances, Re-imbursement of Tuition Fees, Local Travel Concession (LTC), and any other advances as permissible to other regular Govt. servants.
4. He/She is not entitled to subscribe to GPF or CGPS or such other welfare scheme during the period of contract service.
5. He/She have to report at the given posting place within 7 days from the date of joining in the DPO Office, failing which his/her Appointment Order will automatically be treated as cancelled.
6. He/She should be ready to serve at any place/schools including those located in remote/margin areas. In case of refusal the appointment order will be treated as cancelled. No representation what so ever will be entertained.
7. He/She will have to undergo any training for any duration as and when called for. He/She is also to work as Volunteer Instructor of the total Literacy Campaign for the interest of Literacy in Arunachal Pradesh in addition to his/her normal duties.
8. The other Terms and condition of services shall be governed by the relevant rules and order official time being.
