**ORDER**

Sri/Smt. Mirik Pustin is hereby engaged as Junior Teacher on contract basis in the fixed pay of Rs 8500/- (Rupees Eight Thousand Five hundred) only per month with effect from the date of joining in the School in the Govt Primary/Middle School Ranglibee up to 11<sup>th</sup> Year against the centrally sponsored scheme of SSA

**The engagement is subject to the following conditions**

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period
- b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy
- c) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances and any other such allowances
- d) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled
- e) He/she is not entitled to subscribe GPF / CGIS or such other schemes during the period of contract services
- f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt. / Dist. Administration/ Education Department in any addition to his/ her normal duties.
- g) No representation will be accepted for change of posting place
- h) He/she will have to under gone DIET training at concerned DIET for training as and when called for
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules / Orders / Guide lines / Instructions in force time to time
- j) The engaged teacher has to sign an agreement for contract engagement before receiving the engagement order
- k) His/her contractual service will remain valid only upto 31<sup>st</sup> May 2009 and thereafter it be treated automatically terminated and a fresh renewal would be required
- l) He / She will have to report his/her posting place positively within 07 days. His / her Pay will be drawn only after getting posting report through the concerned APO (AE) / ADEO
