	The engagement is subject to the following conditions.	

- a) The contract teacher has no right to claim for regular appointment / regularization of the positive after expiry of contract period.
- b) No earned leave is permissible except casual leave as per central civil service leave rule and per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; win allowances; children educational allowance; reimbursement of tuition fees; leave tracconcession (LTC); special compensatory allowances and any other such allowances.
- d) The contract teacher have to report his/her duty at posting place within 7(seven)days from t date of joining in the concerned DDSE,s office failing which his/her engagement order wattomatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period contract services.
- f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Di Administration/ Education Department in any addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to under gone DIET training at concerned DIET for training as and wh called for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules / Orders / Guide lines / Instruction in force time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving the engagement order.
- k) His/Her contractual service will remain valid <u>till commencement of Summer Vacation w.e.</u>

 16th May'2011 and thereafter it will be treated automatically terminated and a fresh renew would be required for the next academic session.
- I) He / She will have to report for duty at his / her posting place positively on His / her Pay will be drawn only after getting joining report through the concerned A D E the block.
