**Q R D E R**

In pursuance of Govt. approval vide U. O. No. 398 Dtd. 5/12/2002 Shri Satish Chandra Jha is hereby appointed on compassionate ground to officiate as AT(A) in the scale of pay of Rs.4500 -125 -7000/- p.m. plus other allowance as admissible from time to time with effect from date he/ she actually reports for duty to DDSE Kurung Kumey District. The appointment is made purely on compassionate ground as the Govt. of India, Minister of Home Affairs order No. 14014/20/80 Estt (D) Dated 09/12/1993.

The appointment is made vice Shri M.R. Daspurkasthya, AT(A) retired.

The officer shall be on probation for a period of 2(two) years with effect from the date of joining. His continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

The appointment is subject to the following condition :

- The appointment is purely temporary and may be terminated at any time without assigning any reasons. If he wants to resign, he may do so after giving one month's notice or surrendering one-month pay.
- After joining the duty he shall have to take an oath of allegiance of affirmation to the constitutions of India in the prescribed form.
- He will have to produce Medical Fitness Certificate in the prescribed form from an authorized Medical Officer.
- The appointment is subject to police verification and he will be dismissed from Govt. services if any adverse reports are there with immediate effect.
- The other terms and conditions of services which are not specified herein, shall be governed by the relevant rules in force from time to time.
- Shri Satish Chandra Jha shall have to continue for a minimum tenure of 3(three) years terms in his present posting place.
